MARASCHI NO CHERRY CAKE

2-1/4 cups sifted cake fl our 1-1/3 cups granulated sugar 3 teaspoons baking powder 1 teaspoon salt 1/2 cup vegetable oil 1/4 cup maraschi no cherry j ui ce 1 cup maraschino cherries (cut in eighths) 1/2 cup milk 4 large egg whites (unbeaten) 1/2 cup chopped nuts

Sift together in a bowl: the cake flour, granu-lated sugar, baking powder and salt. Add: the vegetable shortening, cherry juice, cherries and milk. Mix with electric mixer at slow speed for two minutes. Then add unbeaten 4 large eqq whites. Beat two more minutes. Fold in the chopped nuts. Bake at 350 degrees for 30-35 minutes.

## **Silent Key**



#### Walter Cronkite, KB2GSD (SK)

Legendary CBS newsman Walter Cronkite, KB2GSD, who held the title of "Most Trusted Man in America," passed away Friday, July 17 after a long illness. He was 92. The avuncu-



lar Cronkite anchored <u>*CBS Evening News*</u> for 19 years until 1981 when he retired. During that time, he reported on such subjects as the Kennedy assassinations, the Civil Rights movement, the Apollo XI lunar landing, Vietnam and the Vietnam-era protests, the Arab-Israeli Six Day War, Watergate and the Begin-Sadat peace accords.

Cronkite, an ARRL member, narrated the 6 minute video <u>Amateur Ra-</u> <u>dio Today</u>. Produced by the ARRL in 2003, the video tells Amateur Radio's public service story to non-hams, focusing on ham radio's part in helping various agencies respond to wildfires in the Western US during 2002, ham radio in space and the role Amateur Radio plays in emergency communications.

# **Paper Chase**

If you have read CQ Magazines' "Results of the 2008 CQ WW DX SSB Contest", you notice it reads "The 2008 CQ WW DX SSB Contest occurred with the solar flux about as low as it can get". If it had said "as low as it can go" you might have been in a limbo contest instead of a radio contest and continued, "Conditions were predicted to be a challenge." Therefore, I decided to continue this month with paper chasing within North American. Paper you have a chance to collect as was done last month with the Original Thirteen Colonies Award. I did contact nine of the thirteen and hope you did better than that. If you worked all but Connecticut your award will show you having worked them all as there was a problem with the Connecticut station and you should not b e а d p е n 1

So what is the award for this month? The Hollenberg Pony Express Station. The first event took place in 2000 and has been an annual event since. The Pony Express existed for the sole purpose of bridging a 2000 mile gap in the telegraph line in 1860. The Pony Express operated only from April 1860 to October 1861. Riders took about 10 days to travel between St. Joseph, MO. and Sacramento, CA. When a telegraph line was finally stretched across the plains and through the mountains, the Ponv Express became а part of history.

You will find the special event on 3.540, 7.040, 14.040 and for the non cw operator 14.240. I received special notice in the 2001 write up of the special when I made my contact. It read in part, "Requests for a Pony Express Special Event Station certificate are coming in from across the country. On the back of one of the QSL cards we received was a note that read 'this was only my second CW contact in 42 years. I practiced all week to get ready for when I would have to use it'. "If I could do it you can too. Their operators are good. Certificates are available from the Crown Amateur Radio Associa-66062.



# **Ohio QSO Party**

We are sending this email to all the clubs in Ohio, hoping you will spread the news and excitement of the upcoming Ohio QSO Party on August 22, 2009. This is the ARRL's "Year of the State QSO Party", and we're hoping to generate the largest Ohio turnout ever!

The Ohio QSO Party is a popular state QSO party, where Ohio hams become the hunted stations. The event is casual and fun, yet you can really rack up the QSOs with modest stations. It's fun trying to work all 88 Ohio counties as well as all the states and Canadian provinces.

Load up anything you have on 10-80m and you will make lots of QSOs! In fact, the best antennas for 40 & 80m are low dipoles. At this time of the solar cycle, most of the QSOs are on 20, 40 & 80m, though keep an eye out on 10 & 15m too. Skip on 10-40m is often "long", so if you are looking for other Ohioans, the best place to look is on 80m, even at the start of the contest in broad daylight.

Each year all 88 Ohio counties see some activity, though many of the lesser populated counties are activated by mobile stations which only make 10-30 QSOs per county. CQ stations in rare counties! Were especially trying to get hams in lesser populated counties to get on the air and make some contacts this year. A few hours on the air will make a big difference in generating activity in all 88 counties.

There are numerous awards (certificates and plaques) available – including a club competition. These are the plaques, available to the top s c o r e r s i n e a c h c a t e g o r y.

With 100w and low wires or verticals, it's pretty easy to rack up many of the states for your WAS award including Alaska and Hawaii. Operate the full 12 hours, and you might find 300-500 QSOs in your log and might complete your WAS. One of the best ways to rack up the QSOs is to balance CQing with S&Ping.

Since everyone is looking for Ohio stations, they will be tuning the bands for Ohio stations who are CQing. For working your fellow Ohioans, a combination of S&P and CQing is effective. An example CQ would be: "CQ CQ this is KB8ABC KB8ABC Ohio QSO Party". You will be surprised that modest stations can work 40-100 QSOs per hour by calling CQ - and you might have a few pileups on you too.

Please join us for the Ohio QSO Party on Saturday August 22, 2009. The OQP starts at noon local time and goes to midnight local. Ohio stations work anyone, and the exchange is a sequential serial number plus your county. Work SSB and CW only on 10-80m. # Test Your Knowledge Answers:

Most of the club knows that we have been having a really bad RF interference with the Packard Special Event and Claude also KB8YTK has the same trouble in his area. I have contacted FCC to help and they have turned it over to the ARRL for their help. Below is the proper procedure for making complaints on power-line noise. Gail KC8LRH

## ARRL/FCC Cooperation Agreement Program

Let's take a step-by-step look at the entire procedure starting from the very beginning:

1) Eliminate the RFI source as being internal to your home and verify it as power-line noise to the best of your ability. Maintain a log of frequencies, noise levels in S-Units, the date, weather and time of day. It can be just as important to log the presence of noise as well as the absence of it.

2) Get the ball rolling as soon as possible! File a complaint with your local utility's customer service immediately after performing step 1 above. And as before, don't forget to maintain an accurate log. Be sure to record each contact and any associated help ticket numbers with your complaint.

3) If, after a reasonable period of time, your utility remains unresponsive to your complaint, contact the ARRL RFI Desk. Sixty days is probably a good approximation, but this can be adjusted on a case-bycase basis. You'll need to provide the name of your utility, plus the name and address of your utility's CEO.

4) The ARRL will send your utility an ARRL letter. Typically, this letter is addressed to your utility's CEO. It describes the FCC /ARRL Cooperative Agreement, pertinent FCC Rules, and includes brochures and includes pamphlets on how to fix the problem. It also urges voluntary cooperation with an offer to help from the ARRL. You will automatically receive a copy of this letter.

5) The ARRL Letter allows 60 days before proceeding to the next step. An extra week or more is also added for mail delivery. During this time, you must cooperate in any reasonable way you can with the utility's RFI Investigator. This includes allowing the investigator to hear the noise and take sample of it at your station. You must also inform the ARRL of any activity or correspondence from the utility regarding your case.

6) If, after 60 days, the utility has failed to make a good faith effort to fix the problem, you need to once again contact the ARRL. **This is an important step, and the only way the ARRL has of knowing the problem has not been resolved.** Should you fail to contact the ARRL at any time during or after this step, your case may incorrectly be assumed to have been resolved. At this time, you must also specify if you want your name and related information removed from the FCC letter as it will appear in the Enforcement Log. Please note that FCC documents such as these are public information. You can however request your name and related information be removed from the public release.

7) The ARRL prepares your case for FCC consideration. Assuming the Commission does not reject your case, the FCC sends an official advisory notice to your utility. This step typically takes up to two weeks.

You do not receive a copy of the FCC letter. It will however be released

in to the Enforcement Log approximately two to four weeks after it is issued. Review the FCC Enforcement Log for your letter. (Alternately, a search for your call sign on the ARRL Web Site is often another convenient approach.) If your letter does not appear in the log for a month after it is issued, you need to inform the ARRL RFI Desk. Here is a link t the FCC Enforcement Log:

8) The FCC letter allows another 60 days for utility to fix or demonstrate a good faith effort to fix the problem. The same rules apply during this time period as with the ARRL Letter. An extra week or more is added for mail delivery you must cooperate in any reasonable way with the utility's RFI Investigator. You must also inform the ARRL of any activity or correspondence from the utility regarding your case.

9) If, after the 60 days allowed by the FCC letter, the utility has failed to make a good faith effort to fix the problem; you need to once again contact the ARRL RFI Help Desk. **As with the previous ARRL Letter, this is an important step.** It is the only way the ARRL and the FCC has of knowing the problem has not been resolved. Should you fail to do this, the ARRL and FCC may incorrectly assume your case is closed.

10) The FCC issues a second notice to the utility. Depending on the specific circumstances of your case, this notice typically allows 15 to 30 days for a response. As with the first FCC Letter, you do not get a copy. You should again look for your letter to appear in the enforcement log. If it doesn't appear after four weeks, you should notify the ARRL RFI Desk.

11) If after the second FCC Notice, the utility fails to demonstrate a good faith effort to resolve the problem, again contact the ARRL Help Desk. The next step is to form a committee to provide an independent assessment of the situation. The committee will generate a report, which the ARRL's RFI Desk will present to the FCC.

The FCC will then make a decision as to whether or not a formal field investigation is in order. Should such an investigation be requested, it is important to understand the outcome will be difficult to reverse. The FCC may or may not decline to take any further action in your case. Monetary forfeitures may also be levied against the utility. This is a risk that most amateurs would obviously prefer to avoid. It is in everyone's best interest to achieve a voluntary resolution with which everyone will be satisfied.
