## A word from the prez

March Events – 3<sup>rd</sup> Annual Trumbull County QSO Party

In the past the VHF Trumbull County Township QSO Party" has been restricted to QSOs only made between stations in Trumbull county. There were some suggestions at past meetings on finding a way to increase amateur participation by opening it up to other counties. So this year is our first attempt to do so.

I'll explain how the contest works now even though it is covered in the "General Rules" and "Contest information" found in this issue of the Q-Match, sometimes some additional explanation can help.

Basically everything stays the same as far as QSOs made within Trumbull County to stations in Trumbull County. The difference is a new category has been added named "Out Of County". A station located outside of Trumbull County that makes contact with any stations within Trumbull County falls into this category. The only difference is the points per contact are .5 per QSO, vs 1 for stations within the county. The multiplier stays the same for both the Trumbull County to Trumbull QSOs as well as the "Out Of Trumbull" (OOT) QSO's. And that multiplier is the total number of different townships worked.

Overall it should be a fun time for everyone who can participate. It would be great to hear some of the newer Hams this year on the air for the contest as it does build good radio operating skills, especially trying to make out that distant "rover" low power station on the other side of the township.

Remember, the nice thing about this contest is it's a nice relaxed contest for you to hone yours skills as an operator, and get some experience operating in a contest environment. But don't worry the "pile ups" are not too bad. HI HI

So I hope to hear and make a QSO with many of you on Saturday, March 15<sup>th</sup>. If you're out driving in Trumbull County and see a black truck with a portable antenna mask with a vertical on A word from the prez (cont. . . .) top along the side of the road, stop by and

#### Arrl news

The FCC has canceled the license of a Michigan Amateur Radio operator and told him he may not apply for another ham ticket until 2007. The Commission took the action against Thomas A. Brothers, ex-KI8BE, of Berkley, because he'd been the operator of an unlicensed FM "pirate" radio station. The FCC has again begun to punish those who go against the rules.

THIRD ANNUAL BILL CRAIGER MEMORIAL TWO METER VHF TRUMBULL COUNTY TOWNSHIP QSO PARTY

#### **GENERAL RULES:**

- 1. Individuals and stations are limited to one entry per contest.
- 2. A transmitter, receiver, or antenna used to contact one or more stations may not subsequently be used under any other call during the contest period.
- 3. Stations may be worked for credit only once per band from any given township. This does not prohibit working a station from more than one township with the same call sign (such as a Rover).
- 4. Retransmitting either or both stations, or use of repeater frequencies is not permitted. 5. This prohibits use of all repeater frequencies.
- 6. Contest entrants may not transmit on repeaters or repeater frequencies for the purpose of soliciting contacts.
- 7. Use of the national simplex frequency, 146.52 MHz, or immediately adjacent guard frequencies is prohibited.
- 8. Contest entrants may not transmit on 146.52 MHz for the purpose of making or soliciting QSO's.
- 9. Only recognized simplex frequencies may be used, such as 144.90 to 145.00; 146.49, .55 and .58 and 147.42.45 .48, .51, .54 and .57 MHz on the 2 meter band.
- 10. A station located precisely on a dividing line between townships must select only one as the location for exchange purposes.
- 11. Rover: One' or two operators of a single station that moves among two or more townships during the course of the contest. A rover vehicle may transport only one station using a single call sign. Rovers sign "rover" on phone contacts.
- 12: Out of County: Any base station or rover outside of Trumbull County, but making contacts with stations in townships within Trumbull County.

#### CONTEST:

- 1. Object: To work as many amateur stations in as many different townships in Trumbull County as possible using authorized frequencies in the 144.00 to 148.00 MHz band.
- 2. Date and contest period: The afternoon of Saturday March 15, 2003. Begins at 02:00 PM and ends at 08:00 PM EST.
- 3. Entry categories: Low power 5 watts or less. Medium power 6 watts through 24 watts. High power 25 watts or more. Rover: any power. Out of County: any power
- 4. Exchange: Call, name, township. Rovers sigh "rover" with exchange.
- 5. Scoring: QSO points count 1 point for each complete contact made with a station within Trumbull County. Multiplier: The total number of townships in Trumbull County worked. QSO points for stations within Trumbull County making contacts with stations outside of Trumbull County is .5.
- Final score: Multiply the number of QSO points by the total number of Multipliers for Final score.
- 6. Miscellaneous: Stations may be worked for credit from more than one township with the same call sign (such as rover).
- 7. Awards: Certificates will be awarded for the top scorer in the following categories. Low power, medium power, high power, rover and out of county.
- 8. Submission: All submissions must be turned over to KB8SVF, Renee McCaman, club secretary, no later than Saturday March 22, 2003. All entries must include a properly completed <u>summary</u> sheet.
